Financial Aid Scholarships 2011-2012

Do I Qualify?

Tuition assistance may be available to help families afford a Christian education for their child. Parents/guardians are expected to be actively involved with the school and their child's education.

Financial Aid Scholarships are for a maximum of \$1000.00 annually per child.

To qualify for tuition assistance, you must meet the following criteria:

1. Your child must be enrolled at San Francisco Adventist School in the fall of 2011.
2. Your child must meet all academic and admissions requirements of San Francisco Adventist School.
3. Your family meets the eligibility guidelines outlined below:

Household Size includes you, your spouse (if living at the same address), and all other family members living at your address for whom you claim financial responsibility on your federal tax form.

Household income includes the total gross income of all household members.

How Does Tuition Assistance Work?

Financial Aid Scholarships will be based on household size and income. These scholarships usually cover \$250, \$500, or \$1000 of the annual tuition. Limited scholarships are available each year.

The scholarships are an annual scholarship and will be divided evenly over the ten-month billing cycle and credited to your account monthly.

The scholarship is awarded for the entire year providing:

1. Your child is accepted to the school;
2. Your family remains financially eligible;
3. Your family keeps current with its payments to the school.

How Do I Apply?

Step One. Refer to the chart to see if your family qualifies financially.

Step Two. Complete the application attached to this information sheet. Please include your completed application, a copy of your 2007 Federal Tax Return (Form 1040) or an official statement regarding Cal Works (AFDC), Social Security, Disability, Worker's Compensation, Retirement Benefits, Foster Care, or Unemployment. In addition, please provide a written commitment of worthy student assistance from your local church.

Please Note: W-2 forms and/or employment pay stubs are not considered acceptable financial documents. Additional information will be requested if necessary.

Step Three. Return all forms and documents to the school. If your family qualifies to receive tuition assistance from San Francisco Adventist School and is awarded a scholarship, you will be notified by mail.

San Francisco Adventist School provides tuition assistance to qualifying families without regard to race, color, religion, national origin, ancestry, sexual orientation or gender.

Tuition Assistance Guidelines

- I understand that all children for which I am asking for tuition assistance must be enrolled in San Francisco Adventist School in the fall of 2008.
- I understand that all children for whom I am seeking tuition assistance must meet all academic and admissions requirements for San Francisco Adventist School.
- I understand that tuition assistance is to be used to assist with tuition and does not cover registration fees or books and materials fees.
- I certify that our family meets the financial eligibility requirements and have submitted acceptable financial documents.
- I understand that San Francisco Adventist School reserves the right to cancel any tuition assistance if my child is not enrolled in School within thirty (30) days of the beginning of the school year.
- I pledge to be actively involved in my child's education and school.
- I understand my child's account from the previous year must be paid before I am awarded any financial aid for the new school year.
- I do not have an unpaid balance at my child's previous school.
